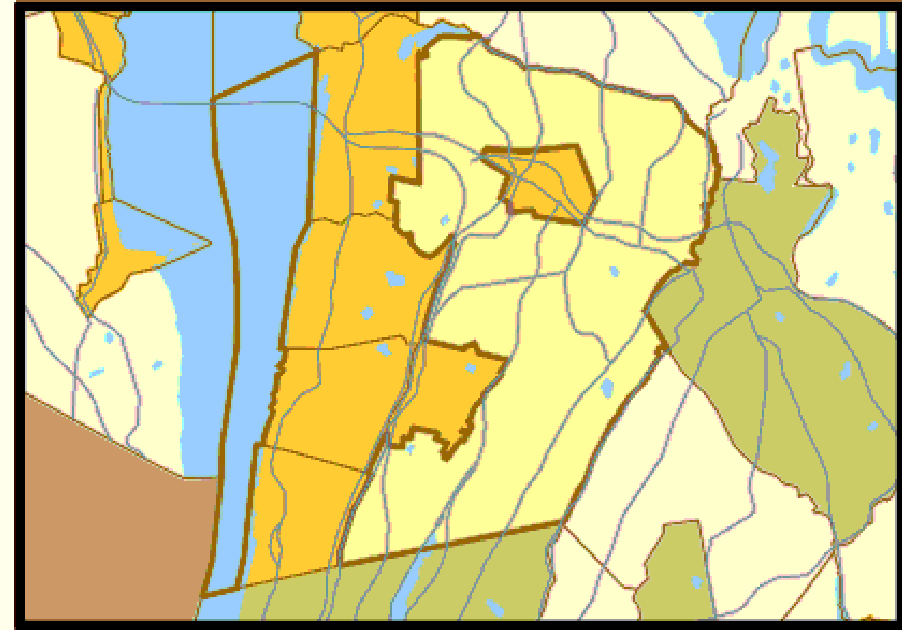

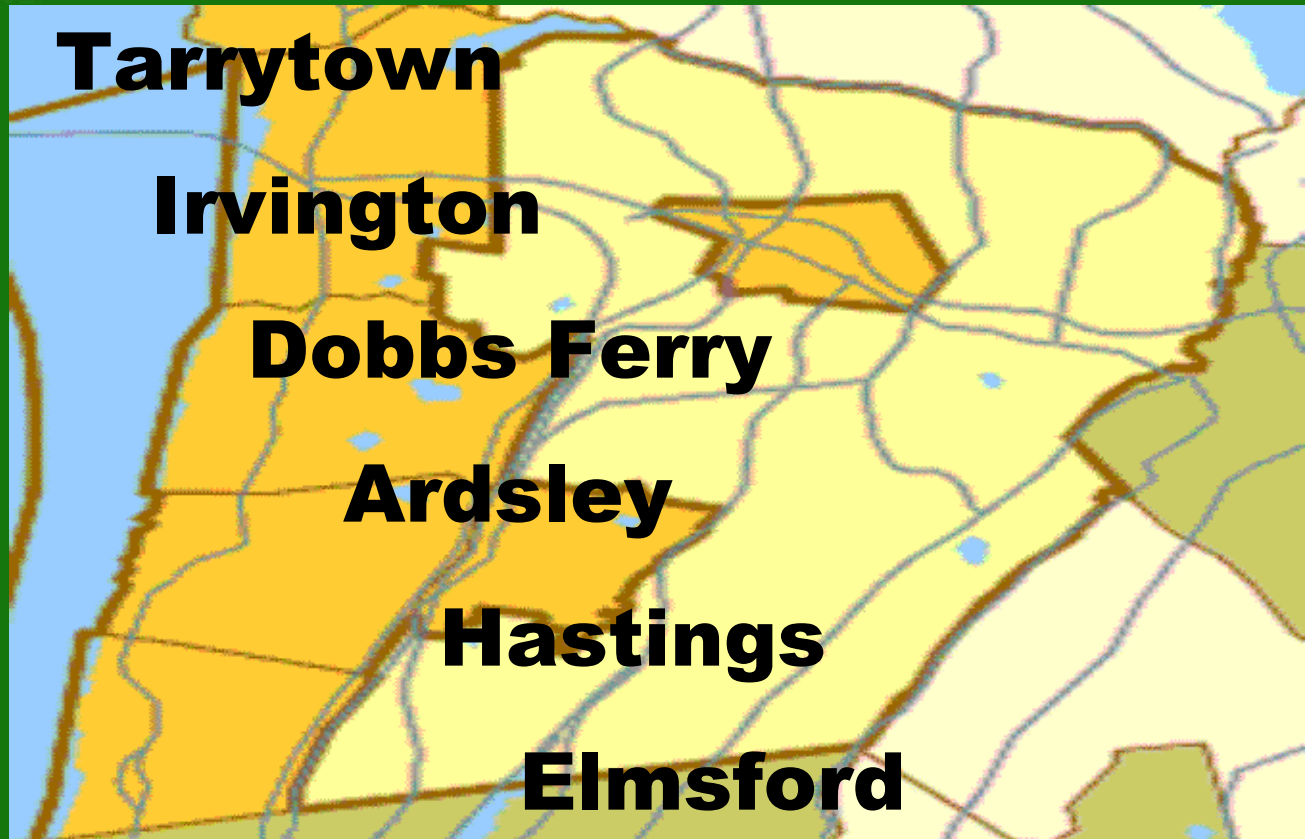

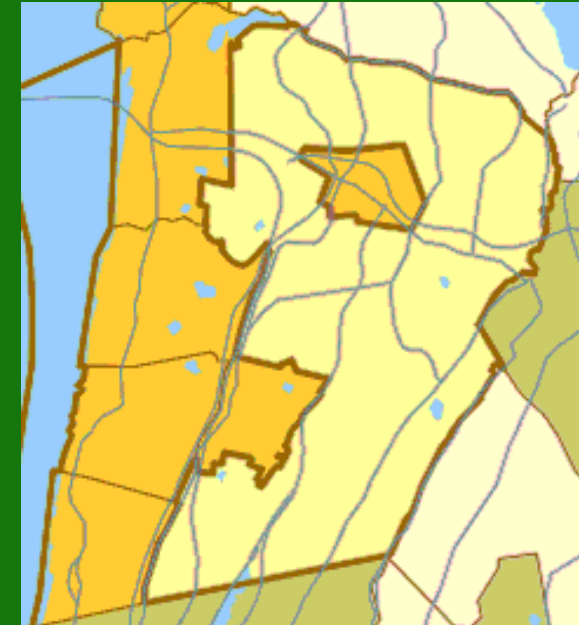


The Villages

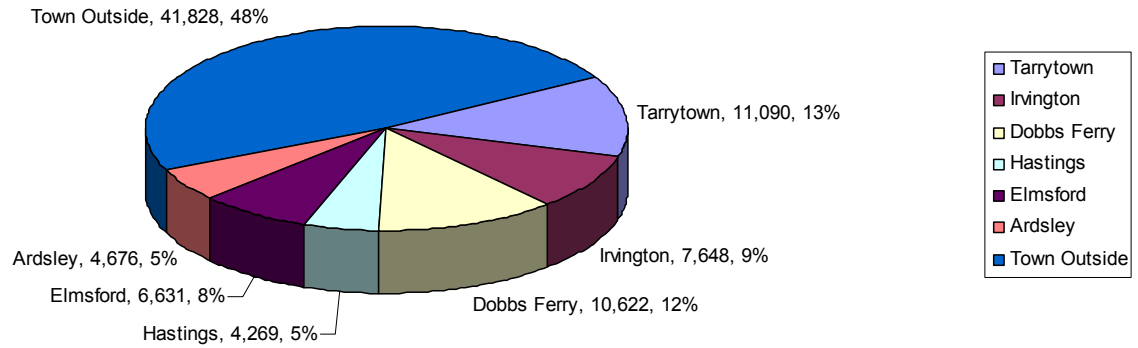

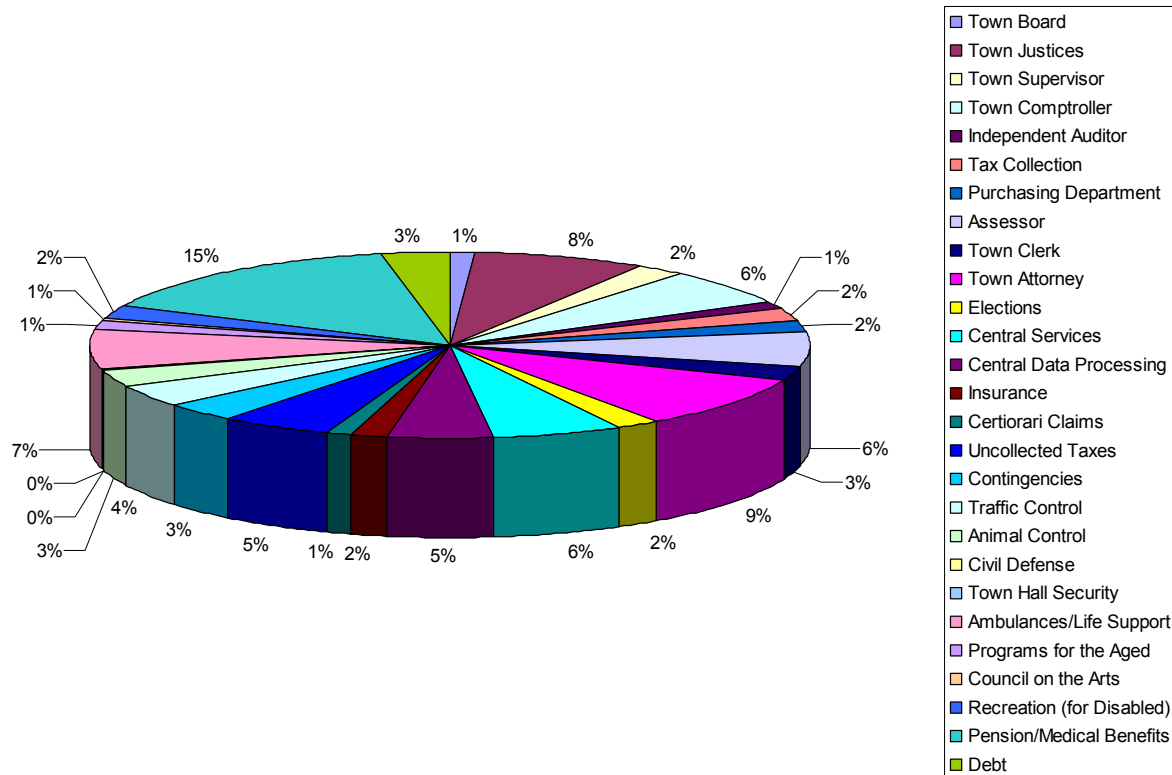

Town Entire Spending Components - 2003

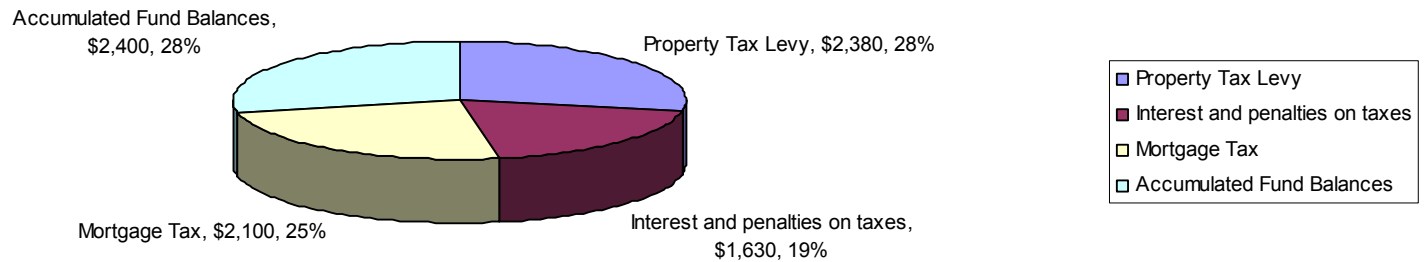

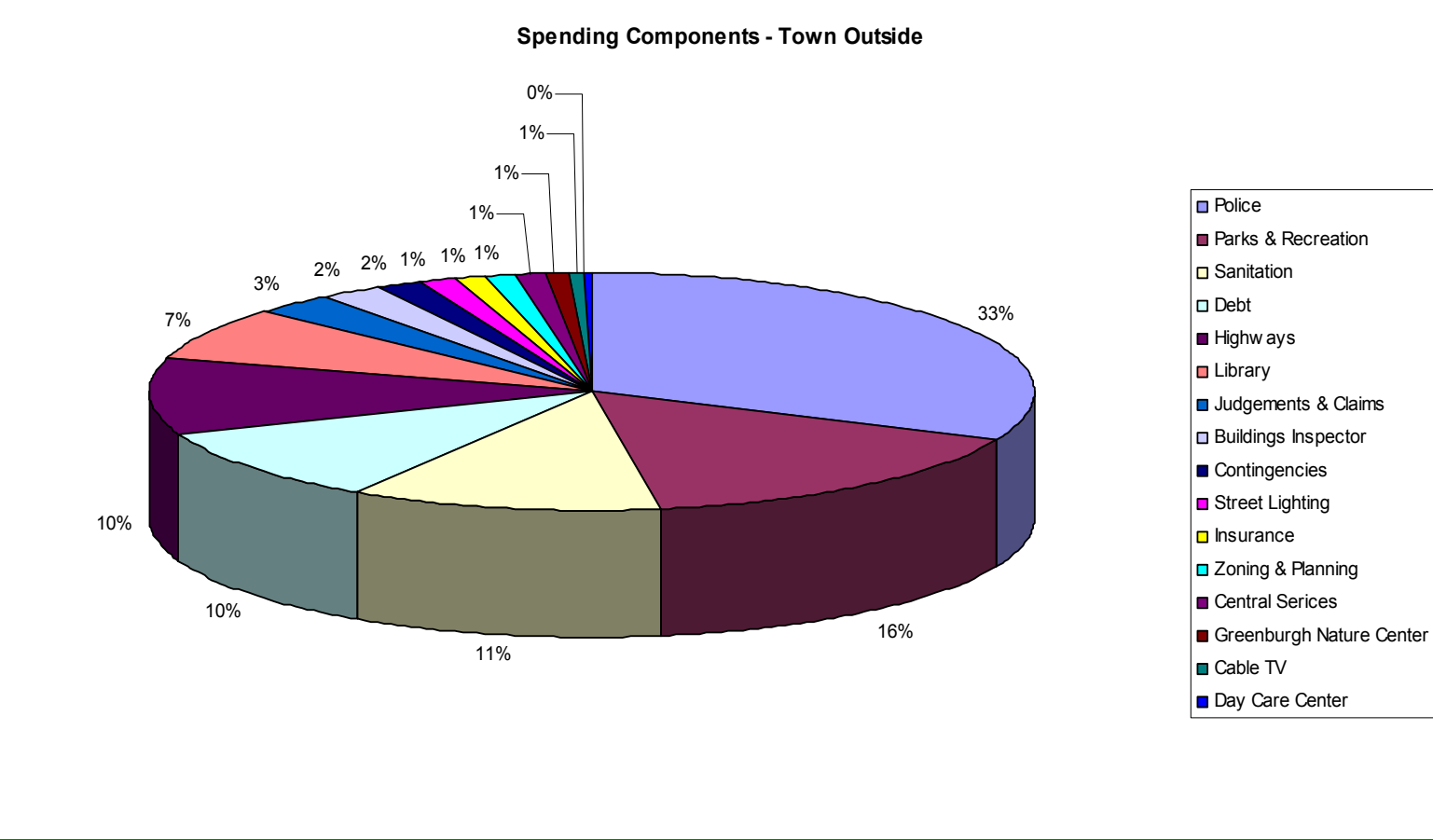

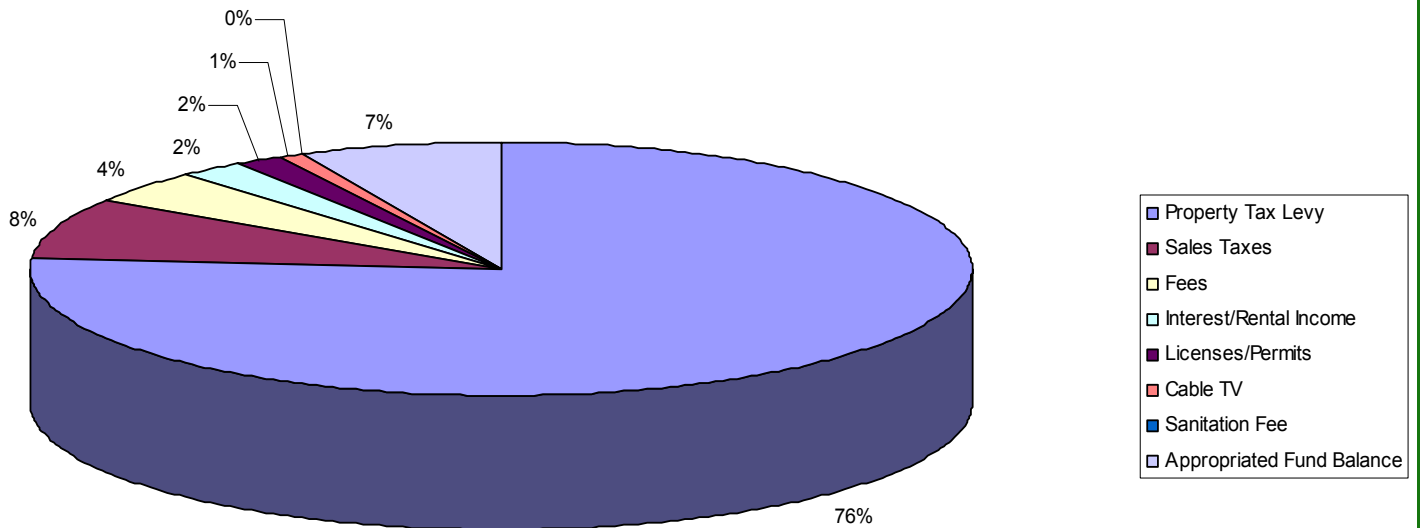
Town Outside Spending Components - 2003

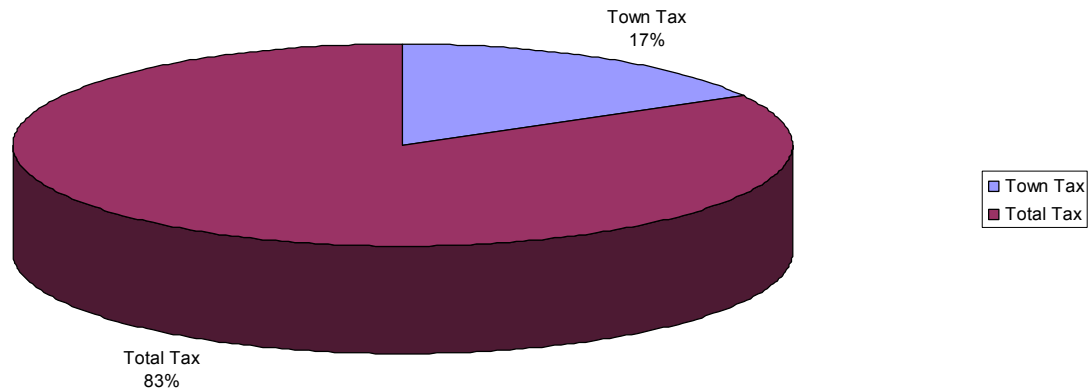

Town Tax as Part of Total Tax Due

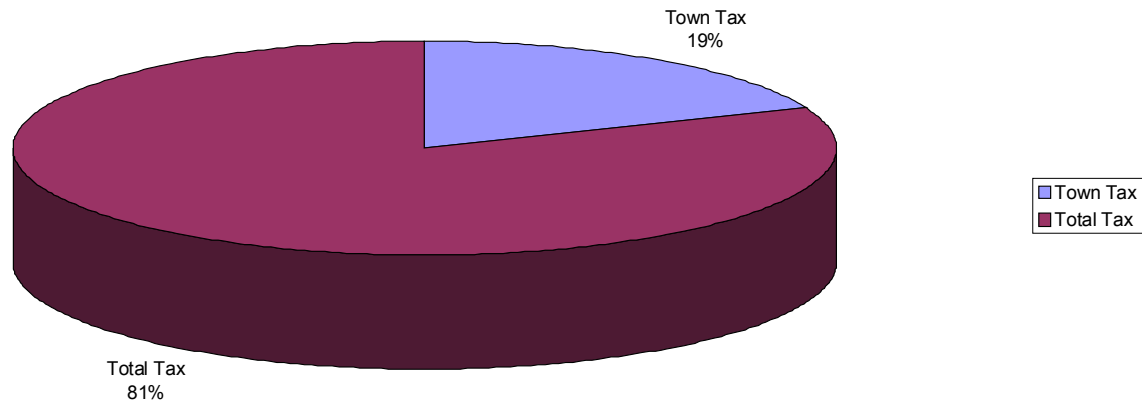
Town Tax as Part of Total Taxes Due
